5.3. Special protective actions for fire-fighters

SECTION 6: Accidental release measures

6.1. Personal precautions, protective equipment and emergency procedures

Evacuate area. Keep away from heat/sparks/open flames/hot surfaces. - No smoking. Use only non-sparking tools. Ventilate the area with fresh air. 6.2. Environmental precautions

6.3. Methods and material for containment and cleaning up

If possible, seal leaking container. Contain spill. Cover spill area with a fire-extinguishing foam.
